**Financial Assistance for Higher Education / Technical education under
BURSARY SCHEME**

F.Y./S.Y./T.Y.B.COM.-B.C.A.-M.COM

Application Forms for the 'BURSARY SCHEME' for all the students of the state of Goa are available in the college office between 9:00 am to 1:30 pm.

All eligible students of B.COM/B.C.A/M.COM class can apply for this scheme. Forms will be issued in the office from 6th November 2020 to 21th November 2020.

Forms for 'BURSARY SCHEME' is sent as an attachment in email, download, print it, fill the form and submit to college office by Thursday, 26st November 2020.

Only eligible students are requested to fill in the Application forms and submit the same in the office on or before Thursday, 26st November 2020 along with necessary documents (attested copies of Marksheets, Fee receipt, Family Income Certificate / Form No. 16 issued by Competent Authority / Income Tax Returns, Aadhar Card Xerox and a copy of Bank Pass Book with (Bank MICR CODE and BANK IFSC CODE) of the student).

Students are instructed to open a saving Bank Account in any Nationalized Bank to the vicinity of educational institution.

The students are hereby informed to note that:

- 1) Those who have not cleared all semesters cannot apply for this scheme.
- 2) Income of the students Parent(s) / Guardian should not exceed Rs. 3, 00,000/- per annum.
- 3) Those students availing the benefits under the Bursary Scheme shall not be eligible to avail similar benefits under any other schemes of Government of Goa. The students would however be permitted to exercise their choice of the scheme(s) to avail similar benefits.
- 4) Scheme operates through GEDC. This will also ensure cross checking so that interest free loan scheme beneficiary do not claim under this scheme and vice versa.

Procedure for application-

- Forms to apply for Bursary Scheme is sent as an attachment in email, download, print it, fill the form and submit to college office by 21st November 2020.
- Students can also collect Bursary forms from College Office between 9:30 am to 1:30 pm.

(2) The following documents are required to be submitted alongwith the application form:

(i) Std. X and Std. XII Passing Certificate and Marksheets of Goa Board of Secondary & Higher Secondary Education/any other board, provided school is located in Goa. In addition to X & XII certificates, graduation passing Certificate and Marksheets of the relevant academic year of the graduation course for students pursuing post graduate courses/programmes.

NOTE: Parents/Guardians having annual income not exceeding Rs. 3, 00, 000 can apply for the said scheme.

(ii) Proof of annual income i.e. any one of the following:—

(a) Form No. 16 issued by the employer in case of parent(s) who are employed. In case both parents are employed then documents of both parents should be submitted.

(b) In case of only one of the parent is working self attested certificate of another parent on 50 Rs NON Judicial stamp paper would be sufficient. (This document need not be notarized).

(a) Income Tax returns of the previous year in case of parent(s) having business or any other profession;

(b) Income Certificate issued by Competent Authority in case of others.

(iii) Proof of Admission to the course/programme and Bonafide student Certificate issued by the Head of Institution.

(iv) Fee Receipts issued by the institution or Fee Structure duly certified by the Head of Institution.

(v) Aadhar Card Copy, Bank passbook Copy (IFSC/MICR)

NOTE: All the Documents (copy) need to be self attested by the applicant.
